Motions:

Mr. Byrne stated that the GWTIDA Finance Committee met to discuss parking rates at the Wildwoods Convention Center. The committee would like to recommend raising the cap from \$15 to \$20 at certain times. It was reiterated by Mr. Siciliano that this would not be the normal course of business, but only on holiday weekends and at certain special events. Mr. April also stated that we have a fiduciary obligation to the owners of the facility. Mr. Siciliano discussed the process for determining daily rates and informed the board that we are hoping to hire an operations employee to oversee parking and other operations tasks and feels that this increase in maximum rate could cover the cost of the new position without taking from our profit percentage, as well as paying for the investment we just made in new parking equipment. Mr. Reidenbach added that we created a traffic hazard over 4th of July weekend and need to be mindful of congestion. Mr. Morey voiced his concerns with the board and stated that he would like to see us reinvest in efforts to increase parking supply. Additional discussion ensued.

Mr. Reidenbach made a motion to increase the cap on parking lot fees at the Wildwoods Convention Center from \$15 to \$20, second by Mr. Patterson.

o **Buildings and Grounds** – Mr. Greenland reported that we are in the process of obtaining 3 prices for the refurbishing of the Wildwoods sign. Also, we will be purchasing 2 bike racks that will be placed at the bottom of the main stairs as a test. If they are utilized, additional bike racks may be purchased at a later time. The new parking lot cash register system is up and running. "Lot Full" signs may also help improve traffic flow. Mr. Reidenbach had questions on the capital improvement budget, which were answered by Mr. Siciliano. NJSEA has approved moving forward on any safety and operational items. Mr. Reidenbach requested an update be given on our solar project, which will be provided by Mr. McNicholas at next

month's meeting. Mr. Reidenbach suggested that the committee look at the window dressings on the Cape May Acme, for possible use on our meeting room windows, should that project be revisited. Mr. Reidenbach commented on the new Earth Cam camera on the Wildwoods sign. He noted that the pictures are both instantaneous and beautiful, and also now include audio. Mr. Rose reported that we received a free HD upgraded camera for our Earth Cam, with HD quality in real time, with sound.

North Wildwood and Wildwood Crest are in agreement, as it is consistent with the 2015 Plan. It is a slow process, however is ongoing. Mr. Reidenbach discussed bikeability and the possibility of tying in Wildwood to the Lower and Middle Township bike paths. Mr. Morey will get an update on bike paths in the county.
