Beach access will not happen at the Wildwoods Convention Center. Mr. Siciliano and Mr. Byrne will attend the City of Wildwood meeting on June 26<sup>th</sup> and will bring a potential plan to use the Bennett Avenue lot. Taking away one row of spaces, there could be room for a potential tunnel. We are willing to work with them, however we would not pay for the project; instead we would assist them in finding funding. This project would benefit many for future infrastructure beach access needs.

Mr. Byrne stated that at the last Buildings & Grounds Committee Meeting, as well as at the last board meeting, the fact that the North end of the building looks bare was discussed. As a result, Mr. Morey worked on some designs for the area and presented them to the board just to see it, however the design will be sent to the Buildings & Grounds Committee. The design is a transparent window film that does not seem to overpower anything on the building.

**Department Updates** – Included in the board packet was an Events Department Update and a Finance Department Update for June 2013.

Mr. Siciliano stated that a press conference was held today to announce the beach concert on August 24<sup>th</sup> in conjunction with the Soul Summer Slam. The Philadelphia Soul and the Coast have teamed up to revitalize the event and bring back flag football, etc. with kids activities, closing with a music festival. The Coast will be bringing in 4 bands, including Fuel, Lit, Hoobastank and Alien Ant Farm. These rock bands will play to the same age group as the flag football tournament. This will be a free concert; however attendees will need a ticket to be admitted. The Soul will offer tickets to season ticket holders, and there will be contests on the radio, then tickets will be available to the public starting on July 1<sup>st</sup>. We are hoping to have 15,000 attendees, and the event will be advertised in the Philadelphia markets. We are trying to make this a full weekend event. Coastal Broadcasting is putting out a major investment. The City of Wildwood will assist with security and in kind services. Thank you to the Philadelphia Soul and Coastal Broadcasting.

Ms. Hanlon suggested that Mr. Rose submit the event to the Superbowl Host Committee. They may be able to assist to promote. Ms. Hanlon will also place the event on the state website. Ms. Hanlon also suggested getting in touch with "Stronger than the Storm".
