Mr. Siciliano discussed the tax match issue and would like to approach the state to get a portion of the tax back to help us do the development and improvement portion of our title. We have been talking with Triad Associates. Senator Van Drew will spearhead once he receives an Executive Summary to show what we would be able to do with the monies received. Michael Zumpino of Triad Associates does a phenomenal job, and he has met with us and Mr. Hasenbalg in Trenton to discuss grants for pre-construction documents and identifying capital project funding. We have received a proposal from Triad in the amount of \$27,500 to handle all meetings, prepare applications, identify capital programs, in order to get support and tax money back. Mr. Byrne added that the host hotel and funding source is to facilitate improvements on the island. This could be our stepping stone for grant money for advertising, etc. Mr. Byrne would love to get support of the Board. This is one of the most important things we can do. Mr. Morey voiced his concerns regarding separating city items vs. tourism items.

Mr. Reidenbach made a motion to enter into a professional services contract with Triad Associates to handle all meetings, prepare applications, identify capital programs, in order to get support for the host hotel and tax money back from the state in order to facilitate improvements on the island, in the amount of \$27,500.00 to be paid for as follows: \$17,500 shall be paid for from the GWTIDA Budget and \$10,000 shall be paid for from the NJSEA Budget), second by Mr. Morey.
