## RESOLUTION NO. 23-01 (OPERATIONS)

THE GREATER WILDWOODS TOURISM IMPROVEMENT AND DEVELOPMENT AUTHORITY RECOMMENDS TO AWARD A CONTRACT FOR STAFFING SERVICES AT THE WILDWOODS CONVENTION CENTER TO ACCU STAFFING SERVICES FOR A PERIOD OF THREE YEARS WITH ONE TWO-YEAR RENEWAL OPTION AT THE BASE RATE OF \$26.16 PER HOUR, ADJUSTED BY THE CONSUMER PRICE INDEX (CPI) ANNUALLY IN AN AMOUNT NOT TO EXCEED \$225,000 PER YEAR, OR \$675,000 FOR THREE YEARS COMMENCING ON JANUARY 1, 2023 AND ENDING ON DECEMBER 31, 2025 BASED ON AVAILABILITY OF FUNDS

WHEREAS, the Greater Wildwoods Tourism Improvement and Development Authority ("GWTIDA") recommends awarding a contract for staffing services at the Wildwoods Convention Center; and

WHEREAS, the said contract shall be awarded to Accu Staffing Services; and

WHEREAS, the said contract shall be for a period of three years with one two-year option; and

WHEREAS, the base rate for said contract shall be in the amount of \$26.16 per hour; and

WHEREAS, said rate shall be adjusted by the CPI annually in an amount not to exceed \$225,000 per year, or \$675,000 for three years; and

WHEREAS, said contract shall commence on January 1, 2023 and end on December 31, 2025; and

NOW, THEREFORE, BE IT RESOLVED, that the Greater Wildwoods Tourism Improvement and Development Authority agrees to award a contract for staffing services at the Wildwoods Convention Center to Accu Staffing Services for a period of three years with one two-year renewal option at the base rate of \$26.16 per hour, adjusted by the Consumer Price Index (CPI) annually in an amount not to exceed \$225,000 per year, or \$675,000 for three years commencing on January 1, 2023 and ending on December 31, 2025 based on availability of funds.
